Liability of permit applicant: 1) The applicant or permittee, as a condition for obtaining an oversized or overweight, or both, permit, shall assume all responsibility for accidents, damage, or injury to any persons or damage to public or private property caused by the movement of any oversized or overweight, or both, vehicle or load covered by the permit while upon Cass County Highways. 2) The applicant or permittee agrees to indemnify and hold harmless the Cass County Government, the Cass County Sheriff's Department, the Cass County Engineer's Office, their officers, and employees from any and all claims resulting directly or indirectly from the movement of an oversize or overweight, or both vehicle or load on any Cass County Highway. The undersigned agrees to comply with all highway regulations from Cass County's Over-Dimensional Vehicle Policy, to take all reasonable safety precautions, and to be responsible for all personal and property damages whatsoever. Applicant further agrees to repair at the expense, and satisfactory to the County, all damages to streets or structures resulting from this movement, such repair to be done in such manner as the County May Elect
