# **Best Management Practices (BMPs)**

Trash not only pollutes water and can harm aquatic life, it can clog storm drains which results in floods during a heavy rain or snowmelt. Best Management Practices (BMPs) are procedures to help prevent pollutants from entering the storm sewer system. Your business can help keep Stormwater ponds, ditches and the Red River clean by applying the following tips.

#### **DUMPSTERS & CONTAINERS**

All trash must be placed inside a dumpster or container until it can be hauled away. Dumpsters should always be kept closed to prevent rainwater from entering. Never place liquid waste, leaky garbage bags or hazardous waste in a dumpster. Routinely check the dumpsters for leaks. If a leak is found immediately contact the trash disposal company.

#### **CLEANING**

Sweep up around dumpsters frequently to prevent trash from accumulating. Try a dry cleanup method instead of using a hose or pressure washer. Use brooms and absorbents such as kitty litter or sawdust to clean up small spills. Dispose of spill materials properly.

### ONLY RAIN IN THE STORM DRAIN

Identify and locate storm drains near your business or home where pollutants could flow from the dumpster or trash bin. Let everyone know that the storm drain flows to the Red River by placing a stencil. Contact the Fargo-Moorhead River Keepers for more information on the Storm Drain Marking Program. If a storm drain is on your private property, check it frequently and clean any debris from the grate. If your private storm drain is clogged, hire a professional to remove the debris.

#### **RECYCLE**

Most trash and debris can be recycled and used for other purposes. Items such as cans, plastic bottles, newspapers, office paper, and cardboard can be recycled. Check for local recycling centers and the types of materials accepted in your area.

## HOUSEHOLD HAZARDOUS WASTE

Do not place items such as paint, household cleaners, automotive fluids, lawn chemicals or other chemicals inside a dumpster or trash can. Take these items to the Fargo Household Hazardous Waste Facility. Visit the City of Fargo website for a list of items accepted at the facility.

#### SPILLS

Keep spill kits in places where they are easily accessible. Immediately report spills that have entered the storm sewer to our staff at SMB-stormwater@casscountynd.gov. For hazardous spills contact your local Fire Department.

Did you know that storm drains are not connected to the sanitary sewer or wastewater treatment plant. Storm drains flow directly to local stormwater ponds, ditches and the Red River. The primary purpose of the storm sewer system is to carry rainwater and snowmelt away from developed areas to prevent flooding. Stormwater pollution comes from a variety of sources, including grease spills, dirt, debris, automotive fluids, pet waste, pesticides, and other hazardous materials. Cass County Government is committed to improving water quality and reducing the amount of pollution entering waterways.
