The undersigned agrees to comply with all highway regulations from Cass County's Overdimensional Vehicle Policy, to take all reasonable safety precautions, and to be responsible for all personal and property damages whatsoever. Applicant further agrees to repair at the expense, and satisfactory to the County, all damages to streets or structures resulting from this movement, such repair to be done in such manner as the County May Elect
